GUIDELINES FOR THE PREVENTION AND TO CONTROL THE SPREAD OF COVID-19 DISEASE AMONG THE STAFFS AND LAB USERS IN CENTRALISED LABORATORY MANAGEMENT CENTRE (CLMC)

All the Centralised Lab Management Centre (CLMC) staff and lab users who will begin their hand-on learning and research session must comply to the precautionary and control steps as follows:

- 1. All the staff and lab user are obligated to fill the CHaSE (link: chase.unisza.edu.my) before entering the CLMC office building or lab.
- 2. Individual with the COVID-19 symptom is NOT ALLOWED to be in the office or laboratory area.
- 3. All students have to undergo a COVID-19 screening test before being allowed to use the lab.
- 4. Please use a face-mask if symptomatic.
- 5. Please cover the mouth with tissue during coughing / sneezing, and dispose of the tissue in a special bin (labeled separately). Please Wash your hand after coughing / sneezing.
- 6. Lab users are required to wash their hands with soap before and after using the lab. The hand washing stations are provided in each lab.
- 7. Avoid touching your eyes, nose or mouth with unwashed hands.
- 8. Maintain at least one (1) meter distance between yourself and others (regardless symptomatic or not).
- 9. Avoid 3C (Crowded place, confined space & Close conversation).
- 10. When dealing with the CLMC administrative office;
 - a. Wash your hands with a hand sanitizer before and after dealing at the counter.
 - b. Fill out the personal information in the registration book provided on the counter.
 - c. Any business is restricted to the counter only except with the permission or request from CLMC to do so.
 - d. Only two (2) students / visitors are allowed to interact at a certain time.
 - e. Notify staff about your health status (if requested).
- 11.Use of research laboratory (graduate and final year students);
 - a. All previously granted access to the lab is automatically canceled. A new application to use the lab must be made starting on May 31, 2020 using the CLMC form (Laboratory Application Form During Covid-19, form no.: CLMC/16/2020-00). Only the approved laboratories will be allowed to use.
 - b. The maximum number of students for research laboratories is limited to five (5) persons at a time (for all research and graduate labs at all three Campuses).

- c. All laboratory applications, bookings or consultations are recommended using online approaches such as websites, WhatsApp applications, SMS or telephone only.
- d. Once the application is approved, students will need to register at the counter provided by CLMC and undergo a body temperature test before entering the lab on a daily basis. Students who do not comply with the health requirements will not allowed to remain in the laboratory area.
- 12. Use of laboratory for teaching and learning (PdP) purposes;
 - a. The number of students will be limited to each practical session according to the capacity of the laboratory space at a time as follows:

Laboratory	Limit number of students
Teaching laboratory (capacity 50/ 40/ 30/ 25 person)	25/ 20/ 15/ 12
Research Laboratory/ Preparation room	5
